



**Community Crime Update**  
**Zone 5 Police Station**  
**Week of Sept 7<sup>th</sup>-13<sup>th</sup>, 2015**



**Homewood / East Hills**

**9/6/15 Attempted Theft from Vehicle – 100 block Kilmer Street.** Victim reports someone broke into her car and rifled through her belongings. Nothing was missing. (170175)

**9/6/15 Theft from Vehicle – 1300 block Collier Street.** Victim reports someone entered her car and stole (2) cell phones, her wallet, and several ID/medical cards. Victim stated the windows in her car were partially-open. (169775)

**9/7/15 Aggravated Assault (Domestic) – 2500 block Park Hill Drive, 11:45pm.** A 51 year-old male victim reported that he was involved in an argument with his girlfriend. The victim gathered his belongings and was leaving the apartment when his girlfriend, **Dionne Brookins, 42, of East Hills**, stabbed him in the back. The victim was transported to the hospital in stable condition. *Officers arrested Brookins and charged her with Aggravated Assault.* (170395)

**9/8/15 Carjacking – Mohler Street & Nolan Court, 1:30am.** A 51 year-old male pizza delivery driver reports that he was carjacked while making a delivery to the above location. The suspect approached the victim's vehicle and brandished a large, black, semi-automatic pistol, then demanded the keys to the vehicle and the driver's money. The suspect drove off in the victim's car. The victim was uninjured. **The suspect is a black male, 15-18 years old, dark complexion, 5'8", a heavy build, clean-shaven, with a shaved head except for the very top. The vehicle is a 2008 black Suzuki SX-2, with PA registration JHB-5601.** (170456)

**9/8/15 Burglary – 2100 block Park Hill Drive, Occurred between 8:00am and 10:00am.** Victim reported that she woke-up to find her ex-boyfriend in her apartment, lying in bed next to her. The suspect has never resided at this location. The victim asked her ex-boyfriend to leave. After he left, the victim noticed items missing from her apartment. The suspect was identified as **Chad Goggins, 23, of Turtle Creek.** Officers will obtain an arrest warrant. *Goggins will be charged with Burglary.* (170667)

**9/8/15 Burglary – 2500 Park Hill Drive, Occurred between 9/6 at 6:00pm and 9/8/ at 3:15pm.** Victim came home after two days to find her back door was wide open. Her 65" Samsung TV, a silver iPad, and (2) pair of shoes had been stolen. (170799)

**9/9/15 Aggravated Assault(shooting)-7300 block of Formosa Way 8:22pm.**

A 23 year old male reported that he was shot by an unknown assailant while attending a candle vigil at the above location. The victim sustained a gunshot wound to his right foot and could not provide any information on suspects. The victim was transported to the hospital in good condition. (171781)

**9/10/15 Burglary-7900 block of Madiera st. between 9/10/15 at 1800hrs. and 9/12/15 at 1832hrs.** The victim returned to her residence and discovered that her home had been burglarized. It appeared the suspect made entry through a basement window and stole a big screen TV and other electronics items. (173953)

**9/10/15 Aggravated Assault (Shooting) – 7000 block Chaucer Street, 8:00am.** A 13 year-old male victim reports that (4) unknown males fired (3) shots at him as he was walking down the street. The suspects were described as black males, all about 5'8", thin builds, wearing dark clothing. It should be noted that the victim was not injured, a crime scene could not be located, the ShotSpotter system did not activate, and neighbors outside in the area at the time told officers they did not hear any shots. This is under investigation by Zone 5 plainclothes detectives. (172044)

**9/10/15 Arson (Vehicle Fire) – 800 block Inwood Street, 3:00am.** An officer patrolling Inwood Street discovered a vehicle fully-engulfed in flames. After the fire was extinguished, officers found a brick on the hood of the car and obscenities scratched into the car that indicated the act was committed by the owner's ex-girlfriend. Arson Squad is investigating. (171961)

**9/12/15 Burglary – 100 block Standard Av, between 9/11 5:00PM and 9/12 1:55PM.** On the above date the property manager for a vacant rental property discovered a front window broken. Upon entering the residence it was discovered that various tools were misplaced, but nothing appeared to be missing. The property is currently under renovation. (173811)

**9/12/15 Burglary- 7300 Kelly St., between 9/10 6:00PM and 9/12 at 2:00PM.** The victim returned to her residence and discovered the front door to be unlocked. When the victim entered the residence she discovered two televisions missing. There was no forced entry to the residence. (173801)

**9/12/15 Aggravated Assault(shooting)- 7300 block of Race St. 12:07 AM.** Zone 5 Officers responded to a Shot Spotter detection call in the 7300 block of Race St. Upon arrival the Officers spoke to a witness who stated that several people had been shot while standing outside at the above location. Officers located three gunshot victims at the scene. One female victim was transported to the hospital in stable condition and two male victims were listed in critical condition. Five vehicles were also struck by gunfire in this incident. (173420)

**9/13/15 Theft from Vehicle-7100 block of Kedron St., between 9/8 at 1200pm and 9/13 4:30PM.** The victim returned to his parked vehicle and discovered his firearm was stolen from his trunk. The victim believes he may have accidentally unlocked it.

### **Larimer / Lincoln-Lemington**

**9/8/15 Burglary – 900 block Lincoln Avenue, 6:00pm.** Victim reports he arrived home and found DVD's missing from his residence. There were no signs of forced entry. (170914)

**9/8/15 Attempted Burglary – 6200 block Carver Street, 5:00pm.** Victim reports she was home when a known juvenile actor attempted to break into her house. The victim called 911 and officers located the **male, 12, of Larimer**. The victim came to the scene where the juvenile had been stopped and made a positive identification. *The juvenile was arrested and charged with Criminal Attempt - Burglary.* (170891)

### **Bloomfield/Garfield/Friendship**

**9/6/15 Burglary – 700 block Broughton Street, Occurred between 8:00am and 9:00pm.** A 22 year-old female victim reports that someone entered her apartment and stole her Schwinn bike, an iron, school books, and a box of jewelry. There were no signs of forced entry. (169683)

**9/8/15 Robbery – S. Millvale Ave & Liberty Avenue, 8:00pm.** An 18 year-old female victim reports that an unknown male took her cell phone from her back pocket and ran away. No weapon seen. (171007)

**9/9/15 Burglary – 200 block Stratford Avenue, 11:45pm.** A 33 year-old male victim called 911 after he discovered that someone entered his apartment and stole his wallet cash, and credit cards while he was in the laundry room of his building. After checking his bank statement online, the victim noticed that his credit card had already been used at a nearby pizza shop. Zone 5 officers went directly to the pizza shop and learned that the order had not yet been delivered. A few quick-thinking officers devised a creative plan to catch the burglars... One officer donned the delivery driver's uniform and decided to deliver the pizza to the burglars himself (with back-up close by). The mission was a success and **Quashawn Abram, 19, of East Liberty**, was subsequently arrested in the 5400 block of Penn Avenue, where he had requested the pizza be delivered. Abram had the victim's stolen property on him at the time of his arrest. *Abram was charged with Burglary, Receiving Stolen Property, and Access Device Fraud.* (171913)

**9/12/15 Robbery - 300 block of S Mathilda St., 11:00PM.** Officers were dispatched to West Penn hospital, where they met with two victims who reported a robbery. The victims stated they were in the 300 block of S Mathilda when they approached by two black males. One of the males produced a handgun and pointed it at the victims. The victims then ran towards the hospital where they dialed 911. The suspects were described as dark skinned black males both dressed in black about '5' "7" inches tall. (174099)

**9/12/15 Robbery - 300 Gross Street, 11:00PM.** Officers were dispatched for a robbery. The victim informed the officers that he had just been robbed by two males who fled on foot. The suspects took the victim's cellphone and \$50.00 cash, and were armed with a gun and a knife. The responding officers used the victim's cellphone tracking app to locate both suspects, who were eventually detained. The victim was brought to the scene and made a positive identification of both males. Officers also learned that the suspects committed the above robbery on S. Mathilda Street as well. The suspects were identified as **Dramell Robinson, 19, of Garfield, and a 16 year-old male from East Liberty.** *The suspects were arrested and charged with Robbery.* (174101)

### **Stanton Heights/Morningside/Highland Park/East Liberty**

**9/6/15 Aggravated Assault (Domestic) – 600 block Mellon Street, 1:00am.** A 40 year-old female victim reports she was walking down the street with her boyfriend when the two began to argue. Her boyfriend, **Jack Hardy, 47, of East Liberty,** threw her down and assaulted her. The victim stated that Hardy pinned her to the ground, choked her, and threatened to kill her. Hardy then fled. The victim was transported by EMS to the hospital. Officers will obtain an arrest warrant for Jack Hardy. *He will be charged with Aggravated Assault, Terroristic Threats, and Unlawful Restraint.* (169134)

**9/8/15 Burglary – 1000 block Mellon Street, 4:30pm.** A witness called 911 after observing two unknown males running from her neighbor's property. Once the victims returned home, they reported jewelry and other personal items were had been stolen from their home. **Suspect # 1 is a black male, dark complexion, late teens or early 20's, 6'2", thin build, short hair, wearing a white shirt and blue jeans. Suspect # 2 is a black male, dark complexion, late teens or early 20's, 5'9", thin build, royal blue shirt, and black basketball shorts.** (170860)

**9/8/15 Theft from Vehicle – Heberton Street & Glenview Place, 10:20am.**

Victim reports that his laptop was stolen from his unlocked vehicle while he was getting his hair cut. (170702)

**9/8/15 Burglary – 1100 block Heberton Street, 10:45am.** Victim arrived home and heard a noise in the house followed by a loud crash. The victim never saw anyone. Officers arrived and cleared the house using the police K-9. The victim noticed that a ladder belonging to the neighbor was leaning up against her house and one of their storm windows was broken. Nothing was missing from the residence. (170647)

**9/11/15 Burglary-700 block of Sheridan Av., between 9/11 8:15PM and 9/11 10:03PM.** The victim arrived home and discovered a flat screen and television and US currency missing from her residence. The victim noticed an open kitchen window that appeared to be the point of entry into the residence. (173347)

**9/11/15 Theft From Vehicle-5600 Rural street, between 9/11 8:15PM and 9/11/15 10:58AM.** The victim arrived at her vehicle and noticed her front passenger door was open. She then observed that her purse was missing from the vehicle. The victim believes she may have left her door unlocked. (172889)



**Notable Arrests**

**9/12/15 at 7:45pm – Joseph Street & Lenora Street (Larimer) –** A 2-person unit was responding to assist another Zone 5 officer on a traffic stop. While en route, these officers passed a vehicle driving erratically along Larimer Avenue. The driver of this vehicle was eventually identified as **Tyrek Germany, 24, of East Hills**. When Germany passed their marked police car, he accelerated and went through a stop sign without stopping. The officers turned around in an attempt to stop the vehicle, but Germany continued to accelerate, failing to pull over. A brief vehicle pursuit ensued, during which Germany discarded a bag of drugs onto the roadway. Back-up officers recovered the discarded items while the initial officers pursued Germany in his vehicle, then on foot. Germany was eventually

apprehended by officers in the area of Joseph & Lenora Streets, after a brief struggle. Officers later learned the bag that Germany discarded contained over 500 stamp bags of heroin. *Germany was charged with numerous vehicle code violations, as well as felony drug offenses, and Resisting Arrest.* (173994)

**9/11/2015 at 3:23AM- N Euclid & Wellsley St.** Officers were responding to a burglar alarm when they observed a vehicle in the area, traveling slowly with no headlights on. Officers initiated a traffic stop on the vehicle and determined that the driver (later ID as **Julian F Wilson**) was not licensed. They also observed the driver to be very nervous sweating profusely and breathing heavy. The officers then asked the driver to exit the vehicle so they could begin to tow the vehicle. As the driver exited the car he removed an item from his pants pocket and concealed it in the door pocket of the vehicle. Fearing that the driver may be armed the officers conducted a pat down for weapons. During the pat down officers immediately felt what they recognized to be a firearm in the subject's pants pocket. The weapon was recovered and it was found to be stolen. Officers then discovered narcotics in the driver's side door pocket of the vehicle. (172706)
